### **Appropriation of Funds for Two Capital Improvement Projects**

- Consideration of acceptance for the appropriation of funds for two capital improvement projects. **Approval**
  - The first project is funding of the full depth reconstruction and creation of a twenty-four-foot-wide Katahdin Drive between the intersections of Pegasus Street and Allagash Drive at a cost of \$420,654.67. The project would also include revenue to cover change orders related to the collection and treatment of groundwater for PFAS contamination at a cost of \$521,890.93. In order to close out the FY 2023 Capital Improvement Program, there is an unfunded need of \$779,600.
  - These two projects total \$1,079,600 which can be cash flowed through the Capital Reserve \$846,600 (\$420,700 from the Roadway Reserve and \$425,900 from the Capital Reserve account) and the closing property sale closings of \$233,000 scheduled for September 2025.

### **Award of bid to Energy New England**

- Consideration to authorize an award of bid to Energy New England for regional network services and market participant services with ISO New England on behalf of the Brunswick Landing Electric Utility. **Approval**
