Growth Area Boundary Discussion:

Steve Weems provided a summary of the new state law, L.D. 1829, which will impact this discussion. Among other things, the law specifies densities in growth areas, minimum lot sizes in growth areas, and diminishes the role of planning boards with regards to growth area ordinance. It results in local governments being less in control of growth areas, but substantially in control of rural areas.

Jimmy Dealaman presented a new potential draft of the growth zone which is more limited, and which places more land into the limited growth residential zoning. The committee discussed.

Motion to keep the existing map of a potential growth district in the draft plan for public comment.
