**New Business:**

- Jim Nelon recommended that the Cable TV Advisory Committee review the existing 218 TV3 videos to assess:
  - What's current?
  - What's viable and accurate today?
  - What do we need to film to fit in any gaps?

Members of the committee weighed in with thoughts about the review. Dave Watson volunteered to be one of the video reviewers. Jeff Nay advised the committee to work through the town's communications group during the review effort.

- Dave Watson initiated the idea of live broadcast interviews discussing current topics, such as the upcoming Public Works renovation project, the recent purchase of a recreation facility and the Streetscape project. Committee discussion ensued. Dave Watson recommended that town department heads and the town manager could be likely candidates for interviews. Jim Nelon offered the idea of creating a landing page – perhaps titled “Brunswick NOW” – where viewers could watch TV3 live and view On Demand programs without needing to navigate through the town website.
- Jeff Nay recommended that any ideas and programs initiated by the Cable TV Advisory Committee be discussed with the communications group.
