Oversees Town Mall & Special Event Permits





\$587,314**




Decrease of \$27,144

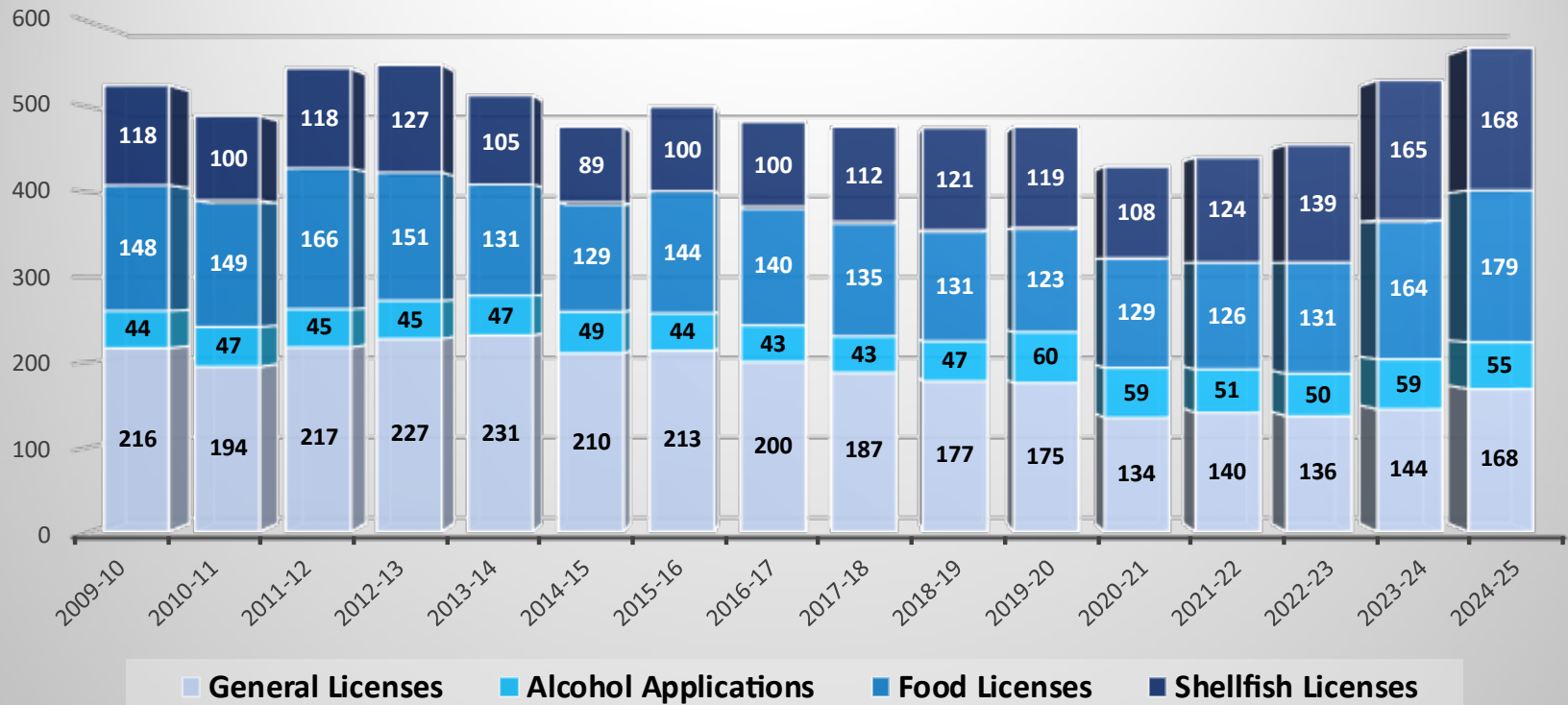
Transactions in 2024

 - *Recreational & Commercial*

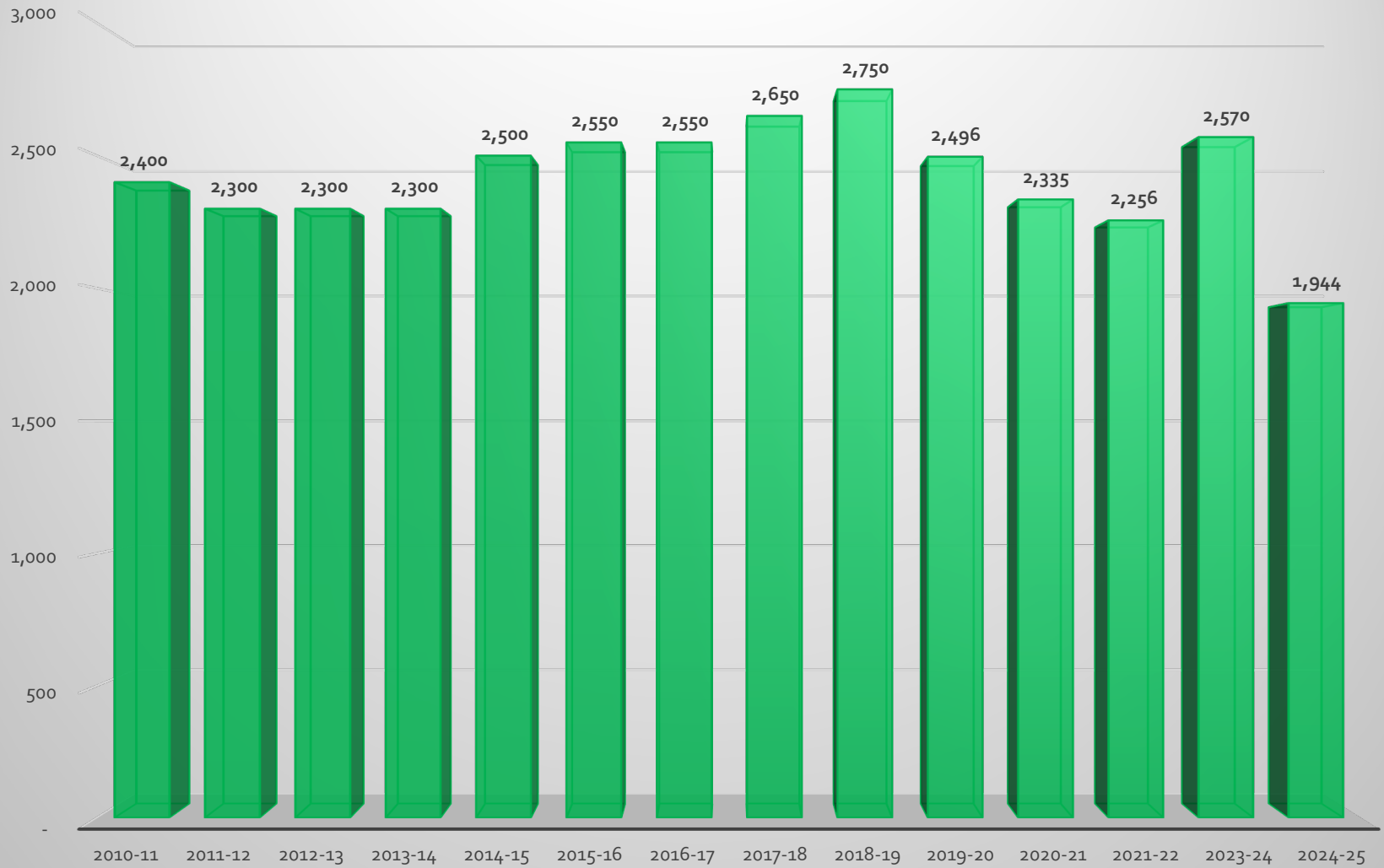
Transactions in 2024

- Reviewed 124 Town Mall & Special Events applications

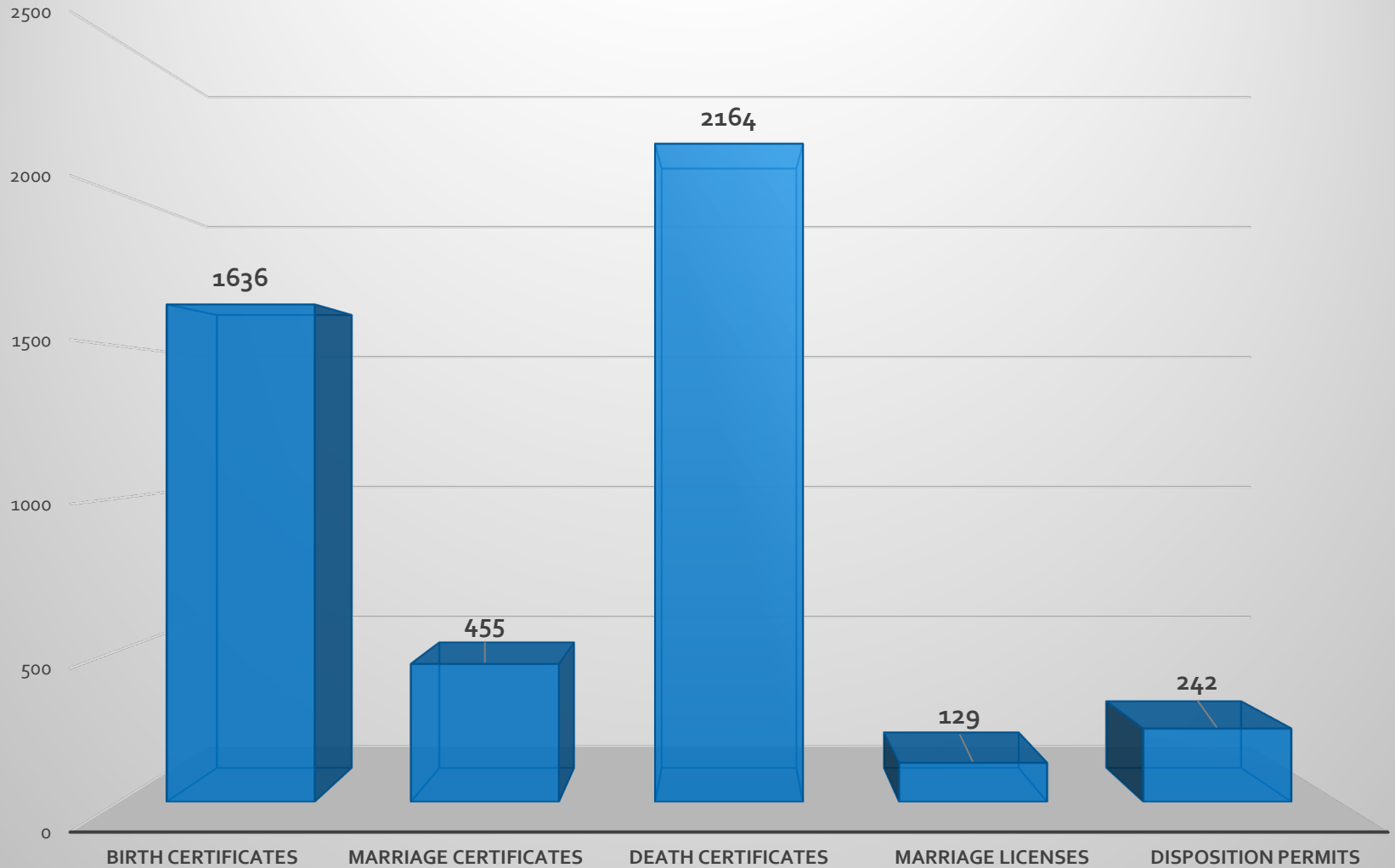

In 2025 there will be 2 elections – June School Budget Referendum & Special School Board At-Large, and the November State & Municipal Election

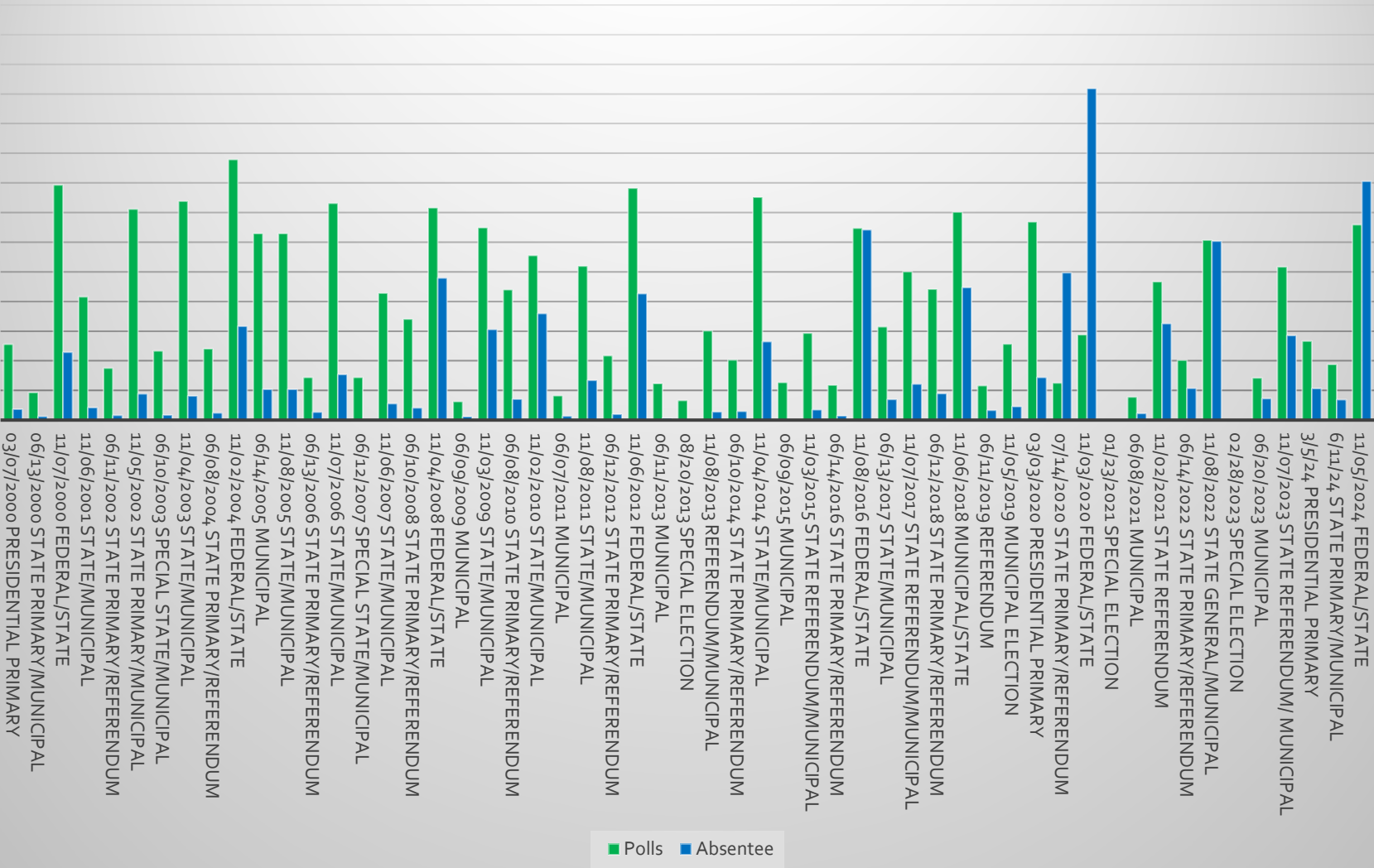
- Preparation begins 3 months prior and includes:
 - Getting election workers for Absentees & Election Day
 - Preparing for and holding Election worker trainings
 - Creating & Testing ballots
 - Responding to many, many election related questions
 - Conducting Absentee Voting

2024 Elections

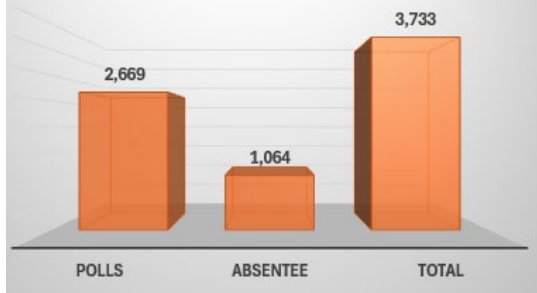
The Town Clerk's Office conducted 3 elections in 2024, supported by 103 election workers who participated in 10 separate training classes. Most workers assisted in more than one election, helping with absentee voting, processing, visiting skilled nursing facilities and working election day.

- 55 Days of Absentee Voting Available
- 11 Days of Absentee Processing
- 36 Hours of Election Training, conducted or received from the State
- 20 Hour work-day for the November 5th Election

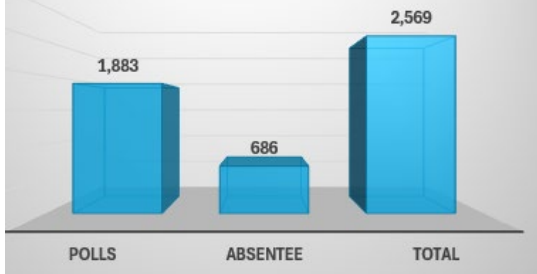
2000-2024 Election Totals



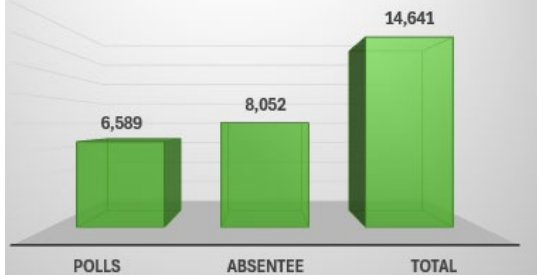
March 5th Presidential Primary



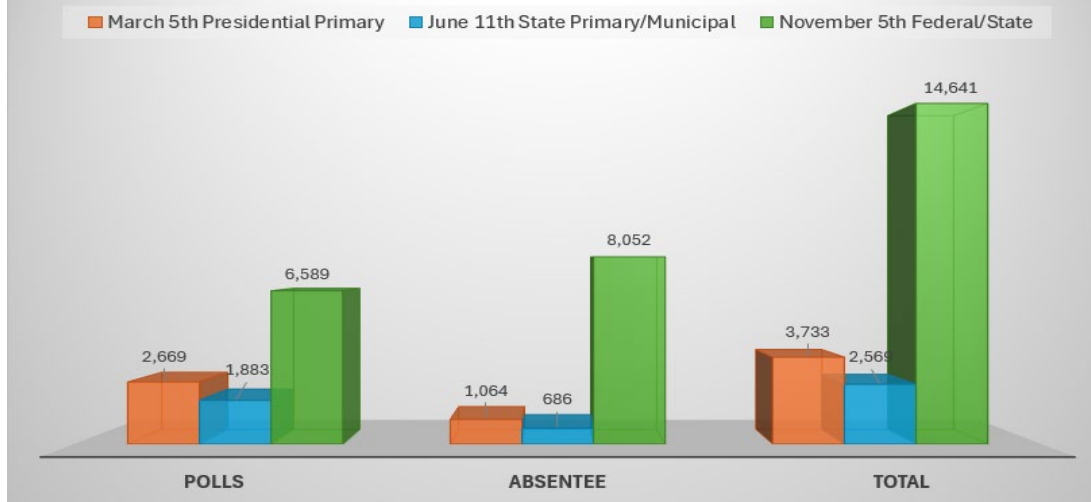
June 11th State Primary/Municipal



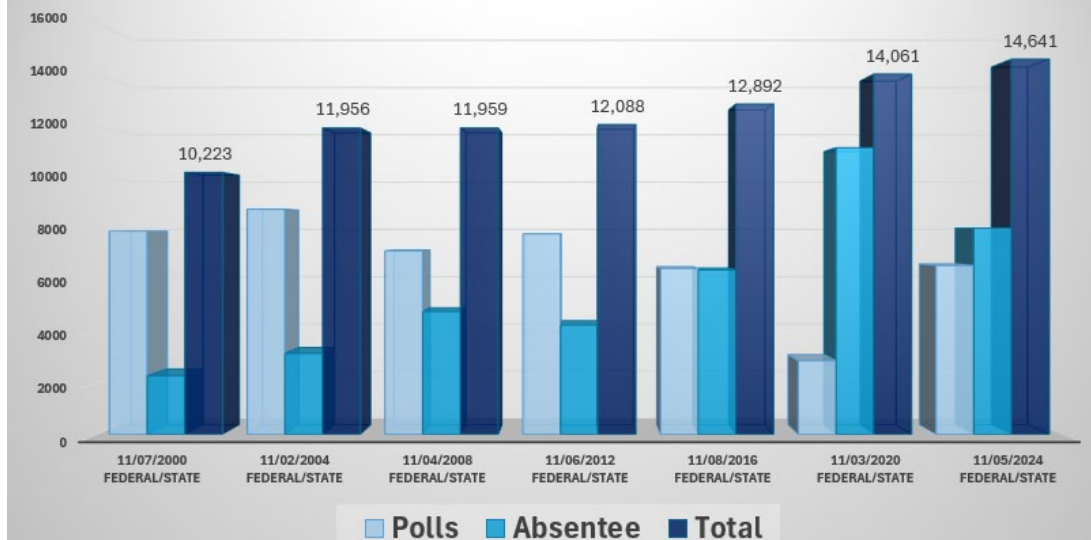
November 5th Federal/State
