2. No excavation work is to commence until DIG SAFE and all underground facility operators have been duly notified of the work 3 business days in advance in accordance with the current State of Maine statutory requirements.
3. All work must conform to the requirements of the Entrance Permit and Chapter 14, Section IV of the Municipal Code of Ordinances.
4. **Fee per Entrance Application:** \$100.00 application fee for each new or altered entrance to serve a single family dwelling, \$150.00 application fee for all other new or altered entrances serving other than a single family dwelling.
